The following applies if your manuscript was supported by a National Institutes of Health (NIH) research grant.

The principal investigators (PIs) of NIH-funded research grants that support work published in peer-reviewed journals have been asked to comply with a new NIH policy to deposit any accepted manuscripts on the PubMed Central website. Since the AJCN owns copyright to all manuscripts published in the AJCN per the agreement signed on submission of the manuscript, we grant the PI permission to deposit this accepted manuscript in PubMed Central according to the NIH request, with the stipulation that the PI accepts any liability that may arise through release of the manuscript in its present form. To avoid this potential liability, the AJCN suggests that the PI delay submission of this manuscript to PubMed Central until our publication office has completed all required copyediting within the next several months. At that point, the corresponding author will be provided with a finished PDF version that will represent the material to be published in the AJCN. Provision of the final PDF version to PubMed Central will avoid all ambiguity that could otherwise result from the presence of one incomplete and the other complete copy of the manuscript.

If the PI decides to submit the unedited version of the manuscript, a further stipulation to the release of the manuscript to the NIH is that it must contain the following statement at the top of the title page:

“This is an uncopyedited author manuscript that has been accepted for publication in The American Journal of Clinical Nutrition, copyright American Society for Nutrition (ASN). This manuscript may not be duplicated or reproduced, other than for personal use or within the rule of ‘Fair Use of Copyrighted Materials’ (section 107, Title 17, US Code) without permission of the copyright owner, the ASN. The final copyedited article, which is the version of record, can be found at <http://www.ajcn.org/>. The ASN disclaims any responsibility or liability for errors or omissions in this version of the manuscript or in any version derived from it by the National Institutes of Health or other parties.”

Regardless of whether the uncopyedited version or the copyedited, final version of the manuscript is submitted to the NIH, the PI must abide by the AJCN policy of making articles free online on our website as well as in the NIH repository 12 months after publication. This will satisfy both the AJCN and NIH policies.

All rights, title, interest and copyright ownership in a manuscript submitted to the American Heart Association is conveyed by the author(s) to the American Heart Association. If a manuscript is supported in whole or part by a funding body, such as the NIH, then authors are authorized to deposit the manuscript in the funding body's designated repository but must specify that it be made public no earlier than 6 months after publication in Arteriosclerosis, Thrombosis, and Vascular Biology.

As of May 2, 2005, the NIH has requested that manuscripts funded in whole or part by NIH funds be deposited in PubMedCentral (PMC). The manuscript to be deposited is the "preprint" form of the manuscript.

When authors deposit their manuscript on the PMC site, authors must designate when the manuscript will be available in the PMC repository. The American Heart Association permits, and requires, that when submitting the manuscript to PMC that authors designate a 6-month delay from the date of final publication by The American Heart Association.

Additionally, the AHA requests that in your final submission to a repository the following disclaimer be added to your manuscript:

The American Heart Association disclaims any responsibility or liability for errors or omissions in this version of the manuscript or in any version derived from it by the National Institutes of Health or other parties.

Several funding bodies have public access policies requesting that grant holders deposit manuscripts in a public repository such as PubMed Central (PMC). Our current licence allows holders of Wellcome Trust, NIH, UK MRC and UK BBSRC grants to comply with these by depositing a copy of the accepted manuscript file in PMC and setting its release date for six months after publication (if you have paid an 'open access' fee, you may release it immediately). Only the unedited raw manuscript should be deposited in PMC (not the typeset journal PDF file). Note also that deposition in PMC only applies to NIH grants awarded after May 2005, Wellcome Trust grants awarded after October 2005 and MRC and BBSRC grants awarded after October 2006. Papers funded by older grants were published under an earlier licence, which does not permit this, and so these should not be deposited.

Science

For research papers created under grants awarded no earlier than 2 May 2005, and for which the authors are required by their funding agencies to make their research results publicly available, authors may implement posting to the funding body's archive or designated repository, no sooner than six months after final publication, of the "accepted version" of the paper, provided the posting is linked back to the original *Science* version and includes the published paper's full reference citation. The "accepted version" is the version of the paper accepted for publication in *Science* after changes resulting from peer review, but before *Science's* editing, image quality

control, and production. This policy does not apply to editorials, reviews, or commentary pieces. In submitting to archives such as PMC, authors of *Science* papers should set the time of public release of the accepted version at six months after final publication in *Science*.
