The National Institutes of Health (NIH) requests that its grantee and intramural authors provide copies of their accepted manuscripts to PubMed Central (PMC) for posting in the PMC Public Access Repository. ASM allows such IAI authors to do so. ASM also allows IAI authors whose work was supported by similar funding agencies that have public access requirements like those of the NIH (e.g., the Wellcome Trust) to post their **accepted manuscripts** in publicly accessible electronic repositories maintained by those funding agencies. If a funding agency does not itself maintain such a site, then ASM allows the author to fulfill that requirement by depositing the manuscript (**not** the typeset article) in an appropriate institutional or subject-based open repository established by a government or noncommercial entity.

Since ASM makes the final, typeset articles from its primary-research journals available free of charge on the ASM Journals and PMC websites 4 months after final publication, ASM recommends that when submitting the accepted manuscript to PMC or a similar public access site, the author specify that the **posting release date for the manuscript be no earlier than 4 months after publication of the typeset article by ASM.**

As of April 7, 2008, the final redacted versions of all research articles resulting from partial or complete support from NIH must be deposited immediately in the NIH repository, PubMed Central. PubMed Central will not release articles to readers for 12 months. While compliance to this NIH mandate is the responsibility of the authors, ASBMB will automatically deposit articles on behalf of authors as a service.

ASBMB/JBC, as copyright holder, grants permission to all authors, for the sole purpose of compliance with the NIH request, to deposit their accepted manuscripts in PubMed Central.

During submission of a manuscript for review, authors will be required to indicate whether or not the work resulted from NIH funding. If NIH funding is involved, and the paper is ultimately accepted for publication, the final redacted version will automatically and immediately be sent to the NIH on behalf of the authors. This will completely satisfy the NIH mandate and authors need do nothing else.

This service will be free for ASBMB members and will cost \$50 for non-members. The \$50 fee covers the cost to the publisher to tag and upload high resolution figures and supply supplemental data from our vendors to PubMed Central. [ASBMB membership currently costs \$140/yr and includes many additional benefits so you may wish to consider joining and receive this service free of charge. For research papers created under grants awarded no earlier than 2 May 2005, and for which the authors are required by their funding agencies to make their research results publicly available, authors may implement posting to the funding body's archive or designated repository, no sooner than six months after final publication, of the "accepted version" of the paper, provided the posting is linked back to the original *Science* version and includes the published paper's full reference citation. The "accepted version" is the version of the paper accepted for publication in *Science* after changes resulting from peer review, but before *Science*'s editing, image quality control, and production. This policy does not apply to editorials, reviews, or commentary pieces. In submitting to archives such as PMC, authors of *Science* papers should set the time of public release of the accepted version at six months after final publication in *Science*.
